Since 2014, PCLP has consulted with over 250 Neighbors Link clients on a variety of immigration matters during legal clinics offered every Friday at the Mount Kisco center. Common immigration issues PCLP has handled include family based petitions, visas, travel documents, asylum, renewal of Legal Permanent Resident Cards, and applications for U.S. naturalization and deferred action. In addition, PCLP helped with 30 urgent cases to defend people who were

## Proud to be a Nonprofit Excellence Award Winner

It was a proud moment for Neighbors Link as we received a top honor at the 10th annual Nonprofit Excellence Awards in December. The silver prize was awarded to Neighbors Link by the Nonprofit Coordinating Committee of New York (NPCC), which recognizes exceptional management practices of nonprofits in New York City, Long Island and Westchester.

An expert 32-member selection committee chose the three winners, also including The Jewish Board of Family and Children's Services (gold) and Per Scholas (bronze), after an intensive application and vetting process that identified excellent management practices. The trio of winners receives a total of \$60,000 in grant money as well as scholarships to the Columbia Business School Executive Education Programs in Social Enterprise.

# Neighbors Link and Local Police Team Up to Build Community Dialogue and Trust



"Trust building" was the shared objective as local police and Neighbors Link families participated in a ground breaking six-week program to proactively address the youth and police tensions that have emerged across the country, particularly in communities of color. Nine families, with children ages 11-15, participated in the recent pilot program that culminated in December.

For example, one session involved role playing where the children played police officers pulling over a car with an immigrant family in it. The immigrant family was played by the police officers. By sharing their preconceived notions and personal stories, participants explored common ground and built mutual respect.

# Citizenship Days Help Immigrants Who Dream of Becoming New Americans

In September of 2016, Clara Rodriguez decided to attend a citizenship drive at Neighbors Link.

"The moment I walked in, I felt like it was my home," she said. Originally from Chile, Clara lived for 45 years in Larchmont, Mamaroneck and Mount Kisco, raising her son with her husband, a U.S. citizen, who passed away three years ago. A social worker in her home country, Clara worked a variety of jobs in Westchester with one goal. "I wanted my son to have a good education."

Clara had taken a computer class at Neighbors Link years prior, and she remembered her experience at the center as a positive one. So, when she saw an article this past fall about the citizenship drive, she called. Clara recalls being warmly greeted by Neighbors Link staff member Ramiro Rincon who assisted with her application and related paperwork.

Clara is one of 130 immigrants who have attended the center's citizenship drives since New York State designated Neighbors Link as one of its official ONA (Office of New Americans) Opportunity Centers in 2016. The citizenship initiative is made possible by legal expertise from the Neighbors Link Community Law Practice and 40 community volunteers.

"It's nice to be involved in something so upbeat and positive," said volunteer Nancy Bauer. She described the events as a huge undertaking for the staff as well as the applicants who come in wellprepared, sometimes with their families. "They are very appreciative of the help



Neighbors Link provides, and they are very motivated to go through the process of becoming American citizens."

Applying for naturalization can take anywhere from four hours to a couple of months depending on

the complexity of the case. To do so, an individual must be a green card holder and meet certain eligibility requirements. The government review process can take six to eight months, during which time an applicant prepares for an interview that includes English language and civics tests.

"While it is their decision to apply, we do

our best to set them up for success," said Ramiro, the center's Workforce Development Manager. "If their English or civics could use some improvement, we encourage ESL and citizenship prep classes at the center."

Clara feels well-prepared for her Manhattan interview and test, and she looks forward to taking the Oath of Allegiance to America at a naturalization ceremony in the next several months. "I told my son, I want to live the rest of my life as an American. This is my country."
