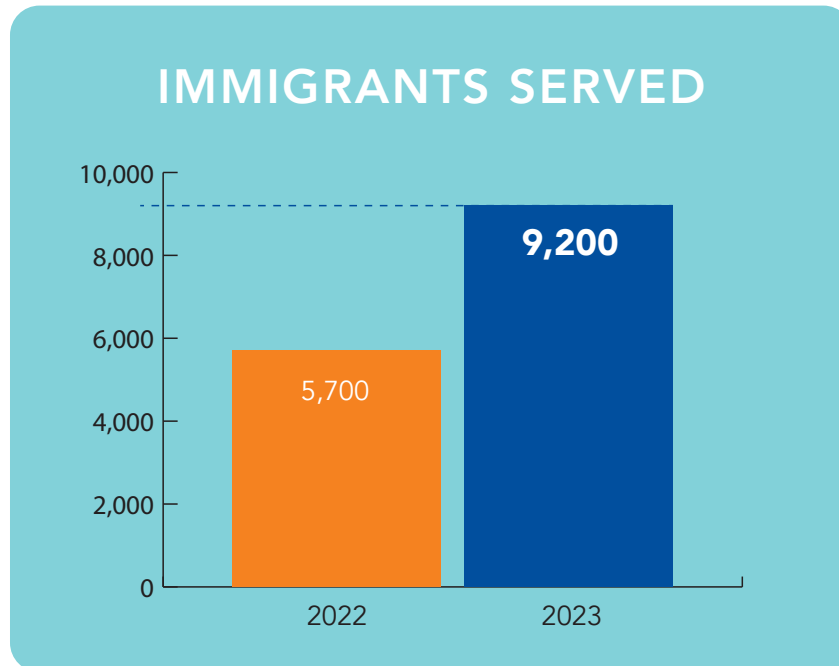

2023 By The Numbers

Neighbors Link works to build stronger communities through immigrant empowerment and integration. Our crucial programs include English classes, programs for parents and children, early childhood programs and academic support for school-age children, workforce development, immigration legal services, crisis support services, advocacy, and more. Key to Neighbors Link's work is creating a shared forum for engagement between new Americans and longer-term residents through volunteerism, cultural awareness training, and civic advocacy. **In 2023, we saw a 62% increase in the number of immigrants served. Much of the increase was serving new arrivals with legal services, English language education, workforce training, computer literacy, and housing.**

NEIGHBORS LINK COMMUNITY LAW PRACTICE SERVED NEARLY 3,000 UNIQUE CLIENTS THROUGH CONSULTATIONS, SCREENINGS, AND CASES. This includes 1,879 cases, with an 86% success rate. The legal practice handled 73% more cases in 2023 than in 2022.



Our newest department, Carreras y Caminos / Careers and Pathways reached **more than 450 people through digital literacy classes, workforce development programs, and individual assistance for job seekers.**



OUR MIGRANT RELOCATION ASSISTANCE PROGRAM (MRAP) IDENTIFIED PERMANENT HOUSING IN WESTCHESTER, MOVED 86 FAMILIES (A TOTAL OF 213 ADULTS AND 169 CHILDREN) FROM SHELTERS, AND STARTED CASE MANAGEMENT SERVICES FOR THEM.

Visioning the Future

Over the past several years, a public health crisis, the rise of a new digital era, and harsh immigration policies have highlighted long-standing inequities in our society. To support their families and be ready for the future, immigrants need tools and training so they can stabilize their lives and succeed. Neighbors Link has combined our deep knowledge of the immigrant community with first-hand crisis relief work to **create a vision for the future where every member of the community has the opportunity to achieve social inclusion and economic mobility.**

With this vision in mind, Neighbors Link launched the Immigrant Empowerment Campaign, aiming to raise \$8.5 million.

Our 3-pronged plan will expand our current holistic array of services and enhance advocacy work for better immigration policies. We will strengthen whole communities by:

WORKFORCE EMPOWERMENT: Providing essential programs for employment success, including computer and internet training, career counseling, increased English language classes, and practical training for in-demand jobs such as health care, hospitality, construction, and the trades.

HIGH-QUALITY IMMIGRATION LEGAL SERVICES: Expanding our legal services with more attorneys and paralegals to meet the growing demand.

INFRASTRUCTURE ENHANCEMENT: We will move our Mount Kisco headquarters to a larger space (adding 2,000+ square feet) to expand services. These will include citizenship preparation classes, more English language learning opportunities, workforce development programs, computer training, and more space for young children to learn and play.

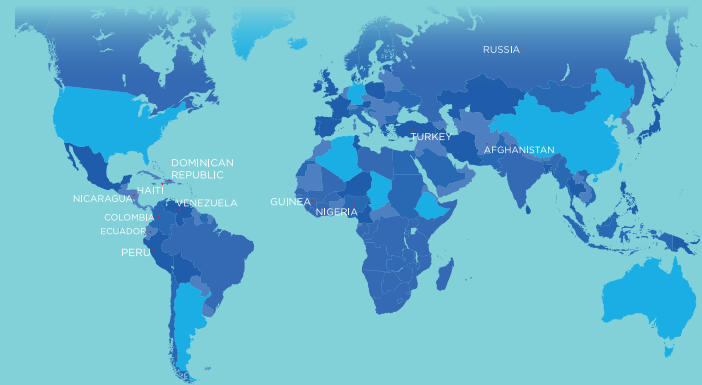
SUPPORTING ASYLUM SEEKERS IN WESTCHESTER AND THE HUDSON VALLEY

In the past 2 years, New York has seen the arrival of many new immigrants seeking asylum. These families are making the difficult decision to leave their home countries to escape extreme violence, poverty, political collapse, and religious persecution. Neighbors Link has been coordinating closely with a variety of government agencies and community partners to support new arrivals.

IMPLEMENTING THE MIGRANT RELOCATION ASSISTANCE PROGRAM (MRAP)

Neighbors Link was selected by the Governor's office as one of only five nonprofit agencies in New York State to assist newly arrived immigrant families with children living in NYC shelters who would like to move to other parts of the state. Through this program, Neighbors Link identifies safe and affordable housing in Westchester County, administers subsidies for rent and utilities for one year, assists with basic needs, and provides case management services for one year.

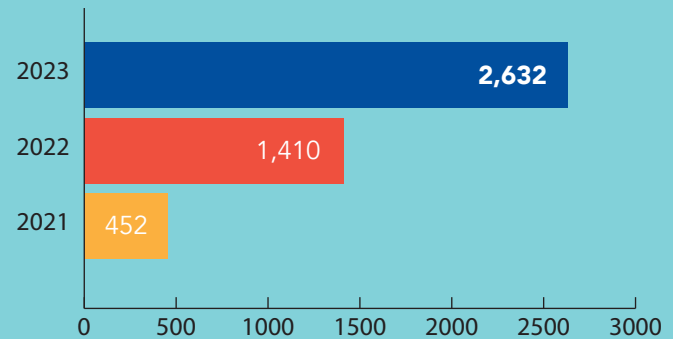

EXPANDING IMMIGRATION LEGAL SERVICES

Neighbors Link Community Law Practice provides free immigration legal services to thousands of New Yorkers each year in matters ranging from deportation defense to naturalization. Over the past two years, we have significantly ramped up our services to assist new arrivals in completing work authorization, asylum, and Temporary Protected Status applications.

Neighbors Link Community Law Practice is now the largest provider of free immigration legal services in the Hudson Valley!

Mental Health & Wellness

MENTAL HEALTH SUPPORT

Many national studies demonstrate that immigrant families often have high levels of stress, trauma, and grief but often have limited access to mental health services. Over the past year, we have worked to introduce several mental health programs and partnerships, including:



1. **Golden Door program with Open Door Family Medical Centers**

Golden Door is a group therapy program that uses a variety of therapeutic methods with an emphasis on art therapy.

2. **Psychoeducation program for parents with RDC Center for Counseling & Human Development**

This program focuses on helping parents understand the impact that distress and trauma have on mental and physical health, decreasing stigma associated with mental health services, promoting adaptive coping skills, and providing information on available community resources.

3. **Mental Health First Aid**

Two Neighbors Link staff members were trained to present the Mental Health First Aid model in Spanish, which teaches participants how to recognize the signs and symptoms that suggest a potential mental health challenge, to be an effective resource, and to offer the appropriate support services for referrals in that situation.

WELLNESS PROGRAMS

Studies consistently show that activities such as exercise or playing a musical instrument can help reduce stress, promote relaxation, boost confidence, and improve social connections. Across our three centers, we have partnered with incredible volunteers to bring regular wellness programs for clients. From **yoga classes** to **acoustic guitar lessons** to **presentations on mental health**, there are opportunities each week for people to **decompress, relax**, and **build relationships**.



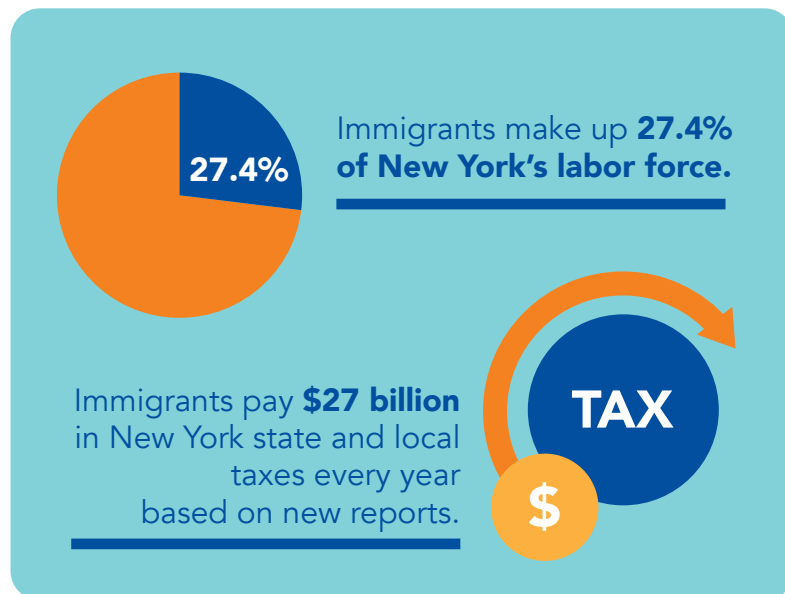
EMPOWERING THE WORKFORCE OF THE FUTURE

Immigration is good for the U.S. economy as a whole and the New York economy specifically. The U.S. birth rate has been trending downward for many years, dropping almost 23% between 2007 and 2022. In addition, without continued inflows of immigrants, the U.S. working-age population will shrink and, by 2040, we will have 6 million fewer working-age people than in 2022. Immigration is key to filling workforce needs, creating new businesses, building up our tax base, and fueling innovation.

The immigrant workforce is already a critical component of New York's economy. Immigrants make up 27% of New York's

labor force and pay \$27.1 billion in New York state and local taxes every year.

At Neighbors Link, we are investing in programming to ensure that immigrant families have the tools they need to participate in the workforce of the future. Our newest department, Carreras y Caminos / Careers and Pathways, provides programs that are critical for employment success, including computer and digital technology training, career counseling, workplace-focused English language classes, and practical training for in-demand jobs in hospitality, the trades, construction, and health care.



NEIGHBORS LINK'S PROGRAMS



NEIGHBORS LINK COMMUNITY

LAW PRACTICE provides a full array of free immigration legal services, including deportation defense, naturalization, Temporary Protected Status, asylum, family reunification, DACA, and Special Immigrant Juvenile Status cases.



THE FAMILY CENTER supports parents raising bilingual, bicultural children to succeed in school and beyond. Programming includes parent education, early childhood development, academic support for students, and partnerships to link families to community resources.



THE WORKER CENTER facilitates connections to employment, advocacy for fair wages, and workforce development training to help people move toward economic stability.



ADVOCACY OPPORTUNITIES allow community members to come together to fight for policies that recognize the dignity and value of each person.



ENGLISH FOR SPEAKERS OF OTHER LANGUAGES (ESOL) programs support full integration for immigrants in our community. All ESOL levels are taught in person and online at Neighbors Link.



COMMUNITY ENGAGEMENT programs address issues related to knowing your rights when interacting with immigration or law enforcement, important updates on immigration policy, and encouraging meaningful dialogue throughout the entire community.



CRISIS AND SUPPORT SERVICES are provided on medical issues, housing, employment, food insecurity, and other issues through an extensive network of partnerships.



VOLUNTEER PROGRAMS bring diverse communities together and inspire a culture of integration and collaboration among residents.



CAREERS AND PATHWAYS, launched in 2023, offers workforce training programs in high-demand fields, support for entrepreneurship, a business center for community use, individual career guidance, and a large number of digital literacy classes for adults.

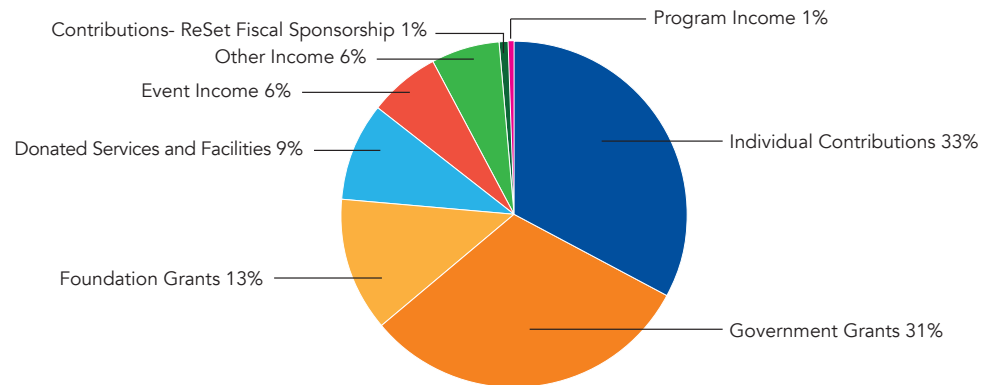

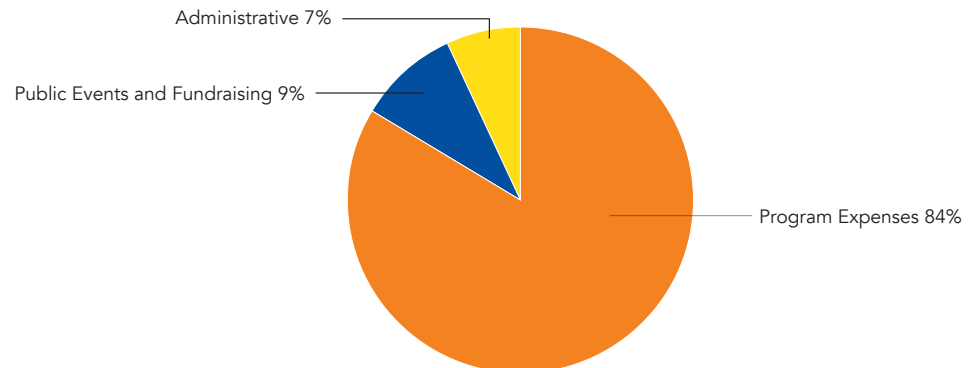
